

# **Provinces are being victimized by a corrupt Health Canada due to their gross ignorance of "pulsed non-thermal radio frequency radiation"**

I believe you will find that my recent letter to Premier Christy Clark of British Columbia (the gist of which is below) could just as easily have been sent to Premier Kathleen Wynne of Ontario who, along with most other provincial and territorial leaders, I have Cc'd here.

World class non-industry scientists and leading health experts from around the globe warn that the most dangerous threat to human health - EVER, is the ongoing unchecked proliferation of wireless radio devices, such as baby monitors, Smart Meters, cell phones, cell phone towers, Wi-Fi routers, cordless phones, laptop and tablet computers, Wi-Fi and WiMAX zones, computer games, etc., all of which emit toxic "low-level, pulsed, non-thermal radio / microwave frequency (RF) radiation.

Honest scientists - those not paid by industry - know that this "non-thermal" radiation "causes, promotes or is linked to" virtually all of today's major diseases: many cancers, leukemia, Alzheimer's, Autism, Dementia, Parkinson's, ADHD, heart problems, cataracts, etc. Yet, tragically, it appears that none of our 10 provincial Chief Public/Health Officers and three Territorial Chief Health Officers -- or even Canada's Chief Public Health Officer, has any education/training/expertise in the long-known harmful biological effects humans experience when constantly exposed to "low-level, pulsed, non-thermal radiation"! This is absolutely disgraceful, given that each of us today (including the PHOs/CPHOs themselves, provincial premiers and even Canada's Prime Minister) is constantly exposed to this form of radiation 24/7/365 basis, in perpetuity! No one can escape this toxic radiation, not even those who promote it!

In British Columbia's case (which is likely the same in all jurisdictions across Canada) due to our PHO's personal ignorance of low-level, pulsed, non-thermal radio / microwave frequency radiation and his gross incompetence, which he has demonstrated for the past 16 years, to this day he simply regurgitates whatever Health Canada tells him regarding what is or is not safe! For that reason he, like his corrupt masters in Health Canada, refuses to recognize that "non-thermal" radiation ("EMR") can be harmful to people. Why? One word: corruption! Informed people, world-class, non-industry scientists and leading health experts globally know that Health Canada is and has for decades been in bed with their corrupt colleagues in the W.H.O. (World Health Organization), ICNIRP (International Commission on Non-ionizing Radiation Protection), IEEE (Institute of Electrical and Electronics Engineers) and the FCC (Federal Communications Commission). Not one - repeat - not one of these agencies will even recognize that non-thermal radiation (EMR) can be harmful! As one, they say that "If the radiation does not heat the skin, it cannot be harmful!" THAT is mankind's problem today, as it surely is for the City of Toronto - the ongoing pandemic corruption within the radiation Regulatory Agencies of the world - and both Health Canada and Industry Canada! As one example of the corruption: just one scientist: Dr. Michael Repacholi, set the so-called 'safe' radiation Exposure Limits for Canada (with the help of Dr. Maria Stuchly), then moved on to ICNIRP (which he founded, becoming the inaugural Chairman, and is now Chairman, Emeritus), following which he moved to the WHO, where he was responsible for also setting their Exposure Limits. All are disgracefully high and very similar! Now, Dr. Repacholi is a full-time consultant for industry!

Nor will BC's PHO, Canada's CPHO, Health Canada, or any of the latter's international bed-mates admit that EMFs (electric and magnetic fields) associated with all electricity, including 60 Hz household wiring, appliances, machinery, tools, high voltage transmission and distribution lines, power transformers, sub stations etc. are harmful to humans, flora and fauna. Yet independent scientists know that an ambient level of just 3-4 mG (milli-gauss) in a home causes Leukemia in children! The recommended 'safe' level of EMFs in a home is 1 mG or less! Yet Health Canada, by contrast, says ambient levels up to 1,000 mG are safe! Their U.S. counterparts, IEEE, allow 9,000 mG; while ICNIRP allows up to 2,000 mG in residences on short term basis, and up to 10,000 mG for short term occupational situations! The WHO shares ICNIRP's standards (remember the name Repacholi? Google: "WHO and Corruption" or "Dr. Repacholi and Corruption" or "Health Canada and Conflict of Interest."

Also, BC's PHO, like Canada's CPHO, and Health Canada, and three of its four international agencies (all save the WHO) do not recognize that there is a condition known globally as electro-hypersensitivity or "EHS". First

reported in 1932 by German scientists, the symptoms of EHS include: headaches, dizziness, disrupted sleep, insomnia, fatigue, nausea, heart palpitations, memory loss, tinnitus, skin rashes, muscle and joint pain, leg and foot pain, tingling, irritability, numbness, nosebleeds, depression, anxiety, etc. Many countries of the world recognize EHS, including even the corrupt WHO, who recognized it in 2005. But not Canada or its ally, the USA!

Safety Code 6 is reviled by eminent honest scientists, leading health experts and informed people around the world! Many countries have 'safety' radiation limits that are far lower (safer) than Canada's, which are virtually the same as the WHO's, ICNIRP's, IEEE's and FCC's. Even the BioInitiative 2007 Report would have required Safety Code 6 to be lowered 10,000 times. The subsequent BioInitiative 2012 Report would require Safety Code 6 be lowered a mind-boggling 3-6 MILLION times!

Given the above - and in the absence of any competent medical professional with accredited expertise in "low-level, pulsed, non-thermal RF radiation" - surely provincial premiers are obliged to personally intervene in order to protect their constituents (as well as themselves) from this, what truly is a crime against humanity -- and a gross violation of every person's Charter of Rights and Freedoms! It goes without saying that wireless Smart Meters should immediately be banned, and those which are already installed should be replaced by harmless analogue meters - at no cost to the customer! And, lastly, customers who have been compelled to pay "Legacy" fees, which amount to legalized extortion, should be fully reimbursed within sixty days! Those unfortunate customers who have had their power cut off should have it immediately restored, again at no cost to them.

On closing, here is an interesting anecdote: residents of Ontario should note that the President and CEO of the CWTA (Canadian Wireless and Telecommunications Association), is fluently bilingual Mr. Bernard Lord, QC, ONB, former two-time premier of New Brunswick - whose job it is to lobby all levels of government across Canada on behalf of his wireless and telecom company members - is also Chairman of Ontario Power Generation!
